

RULES AND REGULATIONS GOVERNING MOUNTAIN VIEW PROVINCE (MVP) HOSTELS

Please note:

1. Hostel accommodation contracts are based on the academic session and **NOT** on a full calendar year.
2. **No Refund Policy**-*Please be advised that all payments made are final and non-refundable.*

SECTION A

Offences Attracting Immediate Expulsion And Without Refund

Any violation of the rules under this section shall result in immediate expulsion from the hostel, with no refund of fees paid.

1. Stealing or theft (taking another person's property without permission).
2. Fighting, including physical confrontation or exchange of abusive words toward fellow students or others.
3. Religious intolerance or discrimination.
4. Disrespect toward hostel staff, including direct or indirect physical confrontation, threats, or interference with staff duties.
5. Drug abuse, including possession, consumption, or distribution of any intoxicating substance such as drugs, smoking (including shisha), alcohol, or any other prohibited substance within the hostel and its environs.
6. Possession of ammunition, explosives, weapons, or any inflammable or hazardous items within the hostel and its environs.
7. Entering or attempting to enter apartments designated for the opposite sex.
8. Any form of harassment, including sexual harassment or sexual assault.

SECTION B

Offences Attracting Immediate Suspension And Without Refund

Any violation of the rules under this section shall result in immediate suspension from the hostel, with no refund of fees paid.

Management reserves the right to exercise discretion on disciplinary matters not expressly stated herein.

1. Students must maintain decorum at all times. Excessive noise, screaming, or disorderly conduct within rooms, common areas, or while watching television, eating, or playing is strictly prohibited.

2. Use of PlayStation or any gaming device on school days is prohibited. Management reserves the right to confiscate such devices.
3. Changing rooms, swapping rooms, or moving into vacant rooms/bed spaces without prior written approval from Management is prohibited.
4. Use of domestic appliances such as heaters, irons, bread toasters, electric kettles, microwaves, or cooking appliances within rooms is prohibited.
5. Students must collectively keep their rooms and surrounding areas clean and organized.
6. Littering within rooms or hostel premises is prohibited.
7. Loud use of auditory or visual devices in shared spaces (rooms, study rooms, common rooms, hallways, canteens) is prohibited.
8. Writing, painting, or engraving on hostel property without authorization is prohibited.
9. Drying clothes on furniture, corridors, or balconies is prohibited.
10. Keeping perishable items in wardrobes that may cause odor, insects, or fungi is prohibited.
11. Curfew is 10:00 p.m. Students must return before or by this time unless prior written permission has been obtained from Management (with parental/guardian consent where applicable).
12. Electrical switches must be turned off when not in use or when leaving the room.
13. Tampering with electrical connections, including the solar system, is strictly prohibited.
14. Reckless driving or speeding within hostel premises is prohibited. Determination of reckless conduct rests with Management.
15. Car racing or stunting within or around hostel premises is prohibited, including participation as a spectator.
16. Ironing of clothes within rooms is prohibited.
17. Changing room locks or keys without authorization is prohibited.
18. Parties or celebrations of any kind within the hostel are prohibited.
19. Students must dress decently at all times. Determination of appropriate dressing rests with Management.
20. Transacting business within the hostel premises is prohibited.
21. Pets of any kind are prohibited.
22. Convening meetings within the hostel premises without prior approval from Management is prohibited.
23. The hostel's social media platform is strictly for information dissemination and entertainment. It shall not be used for disputes. Management reserves the right to remove any member who abuses the platform.

SECTION C

General Regulations

1. All students must comply fully with hostel rules and regulations.
2. Students must be officially registered and allocated a room before bringing luggage into the hostel.
3. Management reserves the right to deny or discontinue accommodation due to misconduct or violation of rules.
4. All visitors must register at the reception/security desk and obtain Management approval.

5. Visitors must leave the hostel no later than 9:00 p.m.
6. Visitors are restricted to designated visitor areas only.
7. No student may accommodate friends or relatives without prior written permission from Management and consent from parent/guardian.
8. Hostel accommodation is not a right and may be withdrawn at Management's discretion.
9. Management is not liable for loss of personal property. Students are advised to safeguard their valuables.
10. Absence of a roommate exceeding 24 hours must be reported immediately to Management.
11. In emergencies, contact security personnel or hostel staff immediately.
12. Management reserves the right to enter or open rooms in cases of rule violations, suspected unlawful activity, or perceived security risk.
13. Students must switch off electrical and electronic appliances when leaving rooms.
14. Students must maintain order when collecting meals and returning used plates.
15. Students must consult Management when faced with difficulties.
16. All hostel accommodation fees are non-refundable once paid.
17. Students must adhere strictly to shuttle service schedules. Management will not bear transport costs for students who miss the shuttle.
18. Room keys must be submitted to designated staff upon departure. Replacement costs for lost keys and associated expenses shall be borne by the student.
